Deliberations & Decisions taken

- 1. To approve minutes of the previous meeting
 - Dr. Tushar Kanti, Director welcomed the newly constituted ARC members and briefed about the various provisions, functions and preventive measures.
 - The minutes of the previous meeting were read and approved by the committee members.
- 2. Anti-ragging Committee -2017-18 annual report-
 - No ragging incident, in any form was reported till date.
 - Orientation about the anti-ragging committee was conducted and anti-ragging squads were vigilant during their rounds. Special session on the "Policies of Anti Ragging Committee" was dedicated in the Orientation Program.
 - The anti-ragging awareness drive through small counseling sessions with Freshers and Seniors were organized.
 - The provision under ARC along with committee members were displayed at all the prominent places in the institute for their wider dissemination.
 - ARC has already taken all the measures to keep campus ragging free in the forthcoming session.
- 3. ARC Action Plan for 2018-19
 - There shall be zero tolerance for any form of ragging in the institutional premises.
 - Strict actions will be taken against any individual found guilty and/or of aiding this misbehaviour.
 - Students should periodically be informed about the effects of ragging and its consequences.
