## Deliberations & Decisions taken

1. To approve the minutes of the previous meeting dated 24.12.2018
  - The minutes of the previous meeting were read and approved.
2. Review of ARC -2018-19 annual report-
  - No incident was reported for ragging, of any kind, on campus in 2018-2019.
  - Anti-ragging campaigns were carried out often, especially in the first month of the academic year.
  - An anti-ragging committee orientation programme was conducted.
  - Regular counselling sessions and awareness campaigns were organised with the students during class hours, in hostels, and in the cafeterias.
  - A pledge against ragging was organized in the campus to sensitise and create awareness among the students.
3. ARC Action Plan for 2019-20

The following items were reviewed following the detailed discussion of the Annual Report from the previous year:

- Ragging of any form is banned in the premises.
- The ARC provision shall be posted at all the noticeable locations in the institute for the wide dissemination of the policies. Along with it the names of members of the committee will also be put up on Flex banners. Any individual found guilty and/or aiding this misbehaviour will be subjected to harsh punishment.
- Both teaching and non-teaching personnel should work together to combat ragging and prevent it. So the committee members and staff

- There should be no exceptions to anti-ragging regulations; they must be adhered strictly.
