Deliberations & Decisions taken

- 1. To approve the minutes of the previous meeting dated 18.02.2022
 - The minutes of the previous meeting were approved by the members of ARC.
- 2. Anti Ragging Committee annual report -2021-22
 - In the academic session 2021-2022, no incident was reported in the institute.
 - The anti-ragging committee organized briefing session in the orientation program on campus.
 - To avoid and keep a check on ragging, ARC inducted anti-ragging squad to make random visits to the hostel and all the vulnerable sites.
 - All the safety & security measures were monitored regulary.
 - Faculty members informally interacted with students to sensitize them on the ill effects of ragging.

3. ARC Action Plan for 2021-22

- Ragging, in any form, is strictly prohibited in the institution.
- All the ARC's provisions and policies should be placed at all the noticeable locations in the institute with the list of the members in the committee for wider dissemination of the same. Any person if found guilty and/orfound aiding this wrongdoing will be subject to punishment.
- a. It was stressed that teaching and non-teaching staff should jointly work and brief each other specially new faculty & staff on ARC's policies to prevent any occurrence of ragging.

- c. Awareness campaigns should be carried out in the institute in the following way-
 - Anti-Ragging Committee should plan briefing session in orientation program.
 - Nukkadnatak should be organised to create awareness among students.
 - Poster making competition to be orgamised on anti ragging theme.
- d. Random visits to the hostel and other places should be frequented by the antiragging squad.
- e. Strict adherence to all the anti-ragging regulations.
- f. It should be ensured that any anti-ragging complaints should be resolved swiftly and completely.
- 4. Any other items with the Chair's approval.
 - As no further matter was raised the meeting ended with a vote of thanks to the Chair.
