- c. In case of non-resolution by mutual negotiation, all disputes arising out of this MOU shall be referred to a sole Arbitrator to be appointed by both the Parties.

- e. No provisions of this MOU may be amended, modified or waived unless by an instrument in writing executed on behalf of each of the Parties by their respective duly authorized officers.
- f. The parties would highlight this MOU and seek gains of media coverage. However, this is clarified that this MOU is not exclusive to either party.
